**INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF SPORTS UNIFORMS FOR
ATHLETES, COACHES AND WORKING COMMITTEE FOR THE 2026 NORTHERN
MINDANAO REGIONAL ATHLETIC ASSOCIATION OF DEPARTMENT OF EDUCATION,
DIVISION OF CAGAYAN DE ORO CITY**

1) The Department of Education, Division of Cagayan de Oro City, through the RA 12314 intends to apply the sum of One Million Nine Hundred Five Thousand Five Hundred Fifty Pesos Only (P1,905,550.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Sports Uniforms for Athletes, Coaches and Working Committee for the 2026 Northern Mindanao Regional Athletic Association of Department of Education, Division of Cagayan de Oro City. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Department of Education, Division of Cagayan de Oro City now invites bids for Supply and Delivery of Sports Uniforms for Athletes, Coaches and Working Committee for the 2026 Northern Mindanao Regional Athletic Association of Department of Education, Division of Cagayan de Oro City using the framework agreement. Delivery of the Goods is required for Twenty (20) Calendar Days. Bidders should have completed, at least five (5) from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4) Interested Bidders may obtain further information from Procurement Service Unit Department of Education – Division of Cagayan de Oro City and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM

5) A complete set of Bidding Documents may be acquired by interested Bidders on January 28, 2026 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (P5,000.00)

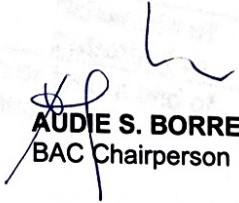

6) The Department of Education – Division of Cagayan de Oro City will hold a Pre-Bid Conference on February 5, 2026 at Board Room, DepEd, Division of Cagayan de Oro City and/or through video conferencing via Google Meet, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before February 18, 2026 8:30 AM Late bids shall not be accepted.
