



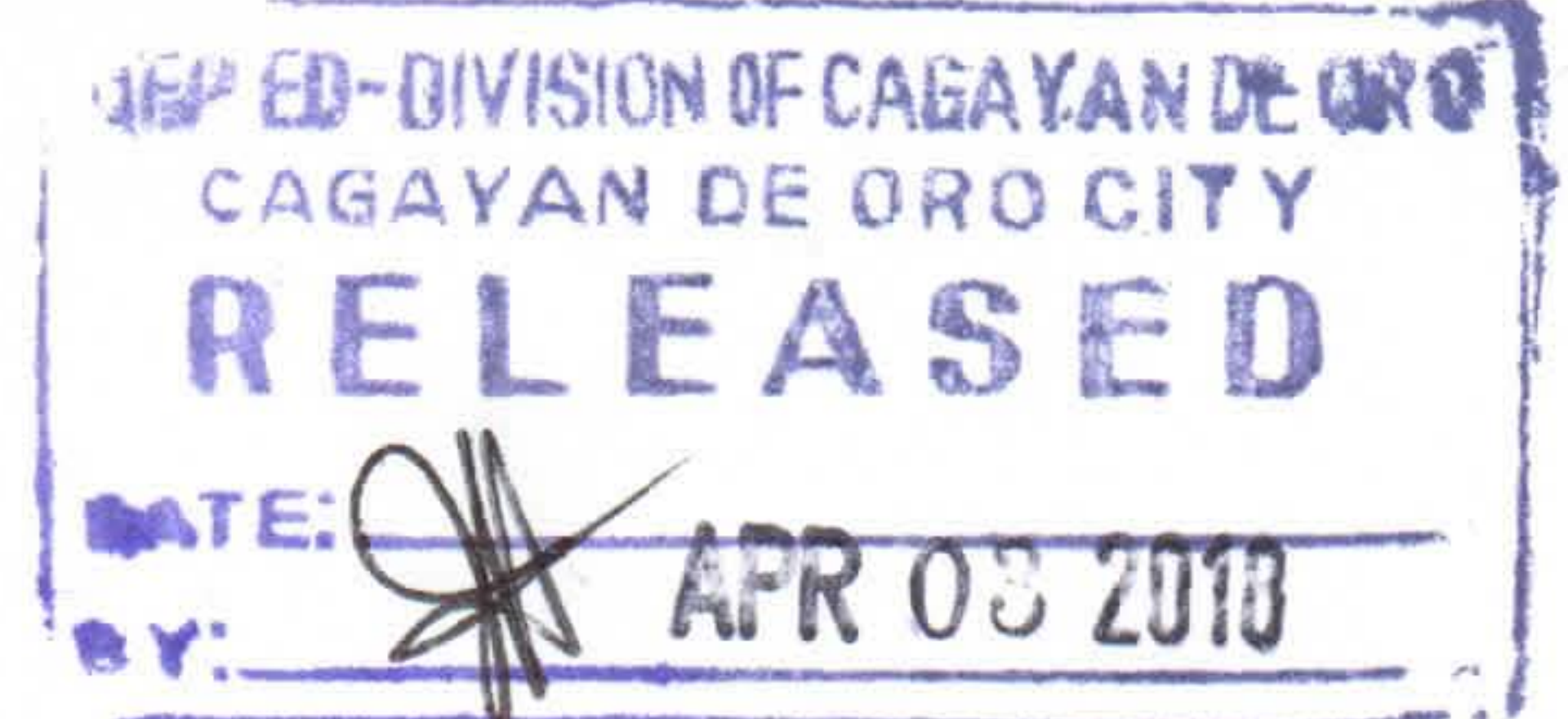

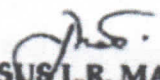

The Committee on Ways and Means of the House of Representatives (HOR) is conducting a study on the Department of Finance (DOF)-proposed Tax Reform for Acceleration and Inclusion (TRAIN) Package II which would affect the preferential income tax rate given to proprietary and non-profit educational institutions offering basic education.
