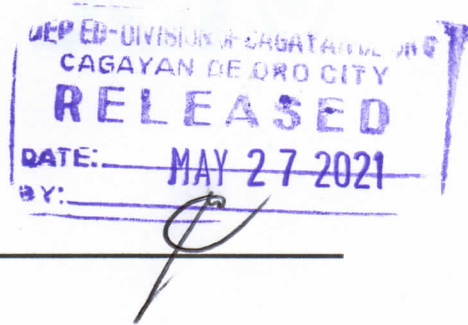

- ARTSADA

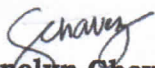
