ACCREDITATION & EQUIVALENCY (ALS A&E) TEST

1. Following DO No. 009, s.2024, the Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025, ALS Accreditation and Equivalency (A&E) Assessment and Certification shall be administered in January 2025.
2. To prepare for the upcoming national assessment, all ALS teachers in the Elementary and Junior High School are directed to conduct Diagnostic Test to all learners in all learning strand from October 21-27, 2024.
3. This aims to provide baseline data for areas that need special intervention.
4. The test questionnaires and answer sheet template can be accessed through the link <https://tinyurl.com/355u7x39> . Results of the test will be submitted through the same link on or before October 31, 2024.
5. Further, ALS teachers are advised to submit an action plan for the conduct of review during the sessions. Document conduct of review sessions and submit accomplishment report.
6. Education Program Specialist for ALS and concerned CTD personnel shall closely monitor the preparations for the test.

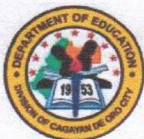
