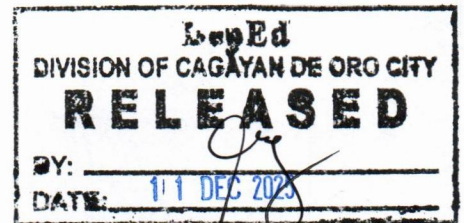

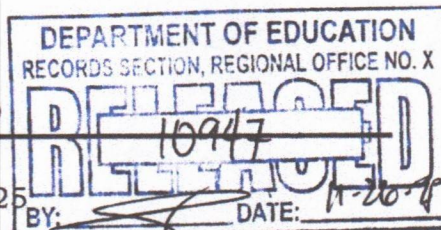

5. Check-in is on December 9, at 2:00 p.m., while check-out is on December 12. The participants must be duly registered through the link provided by the host division.



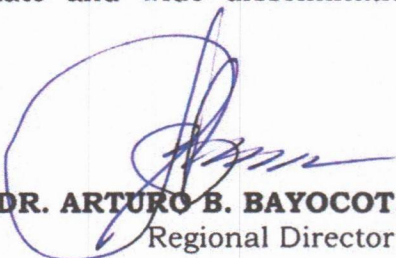

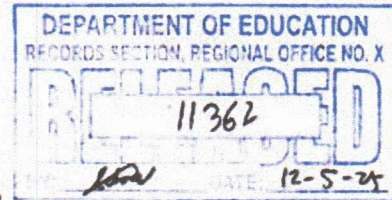

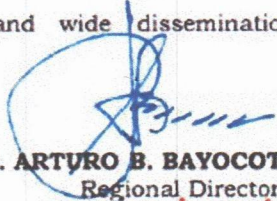
