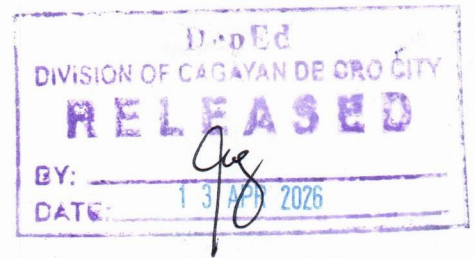

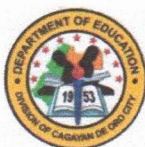

3. This Office directs compliance of this Memorandum.

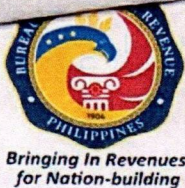

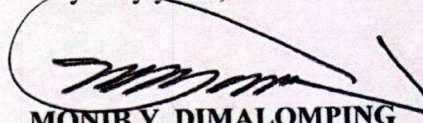
