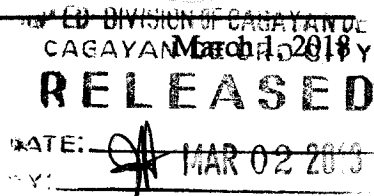

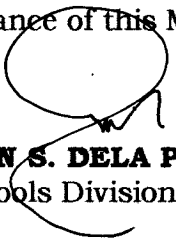
2. You are further informed of the **Planning Meeting on March 5, 2018, 1:00P.M. to 5:00 P.M. at the Division Office.**

3. The Division Federated Supreme Pupil and Student Government COMELEC 2018 shall be the highest governing body of the Student Government Elections 2018.

- a. It shall pursue at all times, the values of impartiality, honesty and integrity in service, renouncing all forms of corruption and acts which are contrary to the rules and regulations on DepEd Order No. 47, s. 2014 otherwise known as **“CONSTITUTION AND BY-LAWS OF THE SUPREME PUPIL GOVERNMENT AND SUPREME STUDENT GOVERNMENT IN ELEMENTARY AND SECONDARY SCHOOLS”** and the **“SUPREME PUPIL GOVERNMENT AND SUPREME STUDENT GOVERNMENT COMMISSION ON ELECTIONS STANDARD ELECTION CODE”** attached on the same DepEd Order.



- b. It shall uphold values, principles, and ideals of the SPG/SSG By-Laws and Constitution, the Division, and the Department of Education.
 - c. It shall be committed in putting these values, principles, and ideals into action by ensuring a free, orderly, and honest election for the student body.
 - d. It shall be an independent agency overseeing the conduct, complaints, and recommending validation or invalidation of the Division Federated SPG/SSG Elections.
 - e. It shall exercise jurisdiction over all matters pertaining to election plebiscite, and referenda within the SPG/SSG COMELEC Standard Election Code.
