

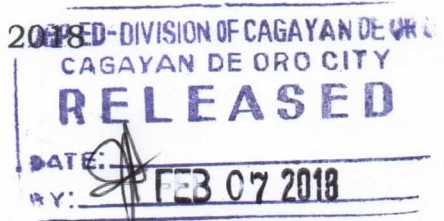

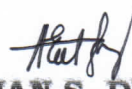

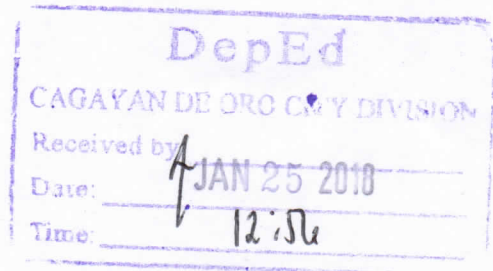

Greetings!

In view of the fast approaching Synchronized Barangay and Sangguniang Kabataan Elections (BSKE) on May 14, 2018, undersigned respectfully requests your good office to please submit not later than February 10, 2018 the list of public school teachers who are willing to serve as Board of Election Tellers subject to the approval of the undersigned. Qualifications of the members of the BET are herein below listed, to wit:

1. Public school teachers (giving preference to those with permanent appointments)
2. Those who served in the May 9, 2016 National and Local Elections or the October 28, 2013 Barangay and Sangguniang Kabataan Elections.
3. Those with specialized training in dealing with persons with disabilities.
4. Persons of good moral character and irreproachable reputation.
5. Registered voter of Cagayan de Oro City;
6. Has never been convicted of any election offense or any other crime punishable by more than six months of imprisonment;
7. Has no pending election offense case against him;
8. Able to speak and write English or the local dialect.

Please be informed also that members of BET should not be related within the fourth civil degree of consanguinity or affinity to any member of BETs or to any candidate to be voted for in the polling place or the candidate's spouse. Members of BETs are preferably in good health, can endure sleepless night and can work under

pressure. If they want to avail of voting inside the precinct where they will serve, they must be a registered voter of the district where they will be assigned.

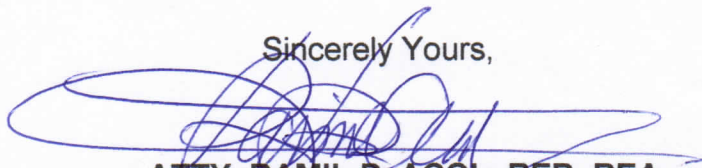
Please submit also list of DepEd Supervisors who are willing to serve as Deputized Supervisors as well as their support staff in polling centers during elections. Deputized supervisors and their support staff need not be a registered voter of the city but must be very familiar with the school facilities and classroom locations.

Undersigned respectfully requests that all lists must be accompanied by certifications that all names indicated thereto are public school teachers.
