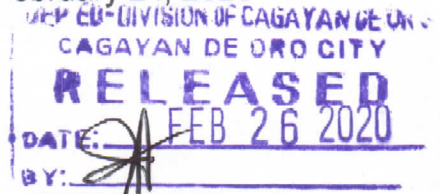

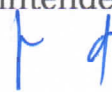

5. Payments for course fees will not be accepted during the orientation as well as the revalida. Hence, all payments should be deposited to BDO with the following details:

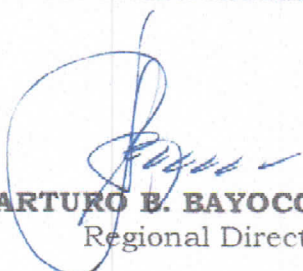

Consequently, may we request you to continue collaborating with SEAMEO INNOTECH for the following activities:

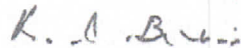
