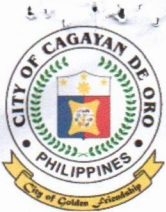

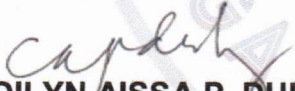

INDIGAY SA PAROL Guidelines

(Open Category)

I. PAROL MAKING MECHANICS:

1. The lantern must be a Traditional Parol which has five points. The contest is open to all individuals, offices and establishments of Cagayan de Oro City, that are interested to join the contest. One (1) entry per individual/office/establishment/barangay.
2. The participants can have his/her own interpretation of a traditional parol, and free to use any medium which the artist desires, provided it adheres to the contest requirements, as follows:
 - Entries must be made of sturdy materials (*with Christmas colors*) that can withstand exposure to all weather, since this will be displayed outside from Dec.2, 2022 to Jan. 9, 2023.
 - Entries must have a creative bearing with the theme of “Pasko de Oro - The Magic of New Beginning”.
 - Entries must have a maximum dimension of the following (*pls. attach layout*):
 - Width - 1.20 meters
 - Height - 1.20 meters
 - Weight - not over 5 kg.
3. The lantern must be well-lighted using LED bulb at 200 wattage.
4. The City Government will check the parol before hanging that it's compliant with the technical requirements to ensure safety.
5. Should the participant decide to include wordings or message on the lantern, please limit to: “**MalipayongPasko** _____” only.
6. Participants must use 1 meter flat cord number 18 to connect parol to the electrical outlet.
7. Materials to be used must be appropriate for outdoor installation/hanging.

II. SCHEDULE OF ACTIVITIES / JUDGING/AWARDING:

1. All interested parties must register with the layout before 18 November 2022 via google form at <https://forms.gle/t8utTcchK7WuYrQV8> or email at paskodeoro@gmail.com.
NO REGISTRATION FEE required.
2. Entries should be placed at your designated post on November 28-29, 2022.
3. First Judging will be on December 1, 2022 in the morning and December 5, 2022 in the evening. Each entry will be provided with a number plate for the judges to easily locate.
4. The entry owner is responsible for maintaining the parol, and make sure that the materials used and the original design are intact.
5. Awarding of winners will be on December 14, 2022 at City Amphitheater.

III. JUDGING CRITERIA:

Criteria	Rating
Artistry Over-all appearance of the Christmas lantern. This includes creativity, attractiveness, and harmony of materials, and that of the lights and the touch of gold. Choice of colors and lights must enhance the attractiveness of the Christmas lantern.	30%
Craftsmanship Symmetry or due proportion of parts, strength of structures, neatness of the work and conformity to the specifications.	30%
Uniqueness Originality of concept and novel use of materials.	20%
Relevance to the Theme The lantern must clearly carry the Christmas theme	20%
TOTAL	100%
