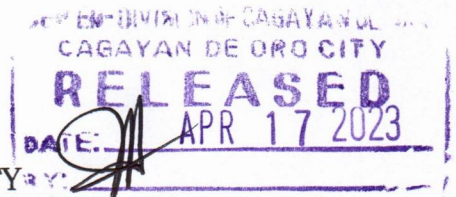

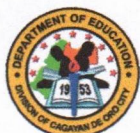

- e. May 3, 2023 -Departure of CDO Delegation to Camiguin and Gingoog City for the third cluster.

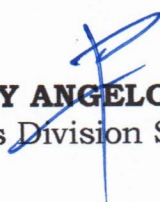
2. All concerned personnel are hereby directed to strictly observe the above-stated schedule and activities.

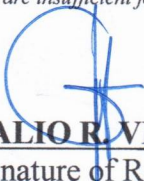

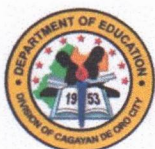
