MEMORANDUM CIRCULAR

SUBJECT : OBSERVANCE OF THE MONTH OF JUNE AS "WE ADVOCATE TIME CONSCIOUSNESS AND HONESTY (W.A.T.C.H.) MONTH"

DATE : APR 25 2023

Presidential Proclamation No. 1782 issued on May 21, 2009, declared the month of June as the "We Advocate Time Consciousness and Honesty (W.A.T.C.H.) Month enjoining all local government units (LGUs), private and public schools and colleges, and other academic institutions, to undertake programs relating thereto, every second week of the month of June. The major goal of Project W.A.T.C.H. is to push forward the recognition of punctuality and honesty as two core values in promoting national renewal and development.

W.A.T.C.H. is an advocacy program jointly undertaken by JCI Senate Philippines, Department of Education, Commission on Higher Education, Technical Education and Skills Development Authority, Philippine Association of Colleges and Universities, PAPSCU, PRISAA, and the Office of the Presidential Assistant for Education, to promote and undertake programs that will instill the value of punctuality and honesty in all sectors of society.

In view of the above, and upon the request of JCI Sen. Cesar S. Ochoa, all Local Chief Executives are encouraged to conduct activities during the second week of June that will infuse deeper awareness of honesty and punctuality among the youth and the entire society, in collaboration with JCI Senate Philippines, the Jaycees and Department of Education located in your areas of jurisdiction.
