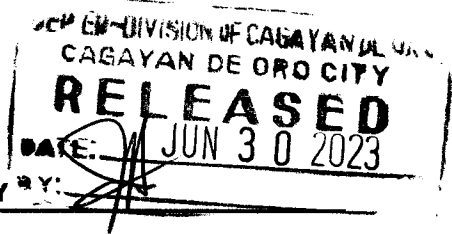

This Office would again request your kind and valuable assistance for our Bid in the Best PESO Award for CY 2022.

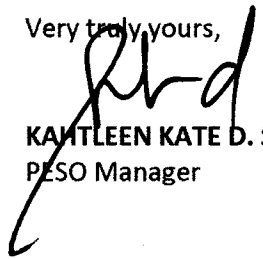
