IMPLEMENTATION OF THE WASTE SEGREGATION IN SCHOOLS

TO: Assistant Schools Division Superintendent
Public Schools District Supervisors
All Elementary and Secondary Public & Private School Heads and Principals
All Solid Waste Management Coordinator
All Others Concerned

1. Article V Section 12 of the City Ordinance No. 13378-2018, also known as the Integrated Ecological Solid Waste Management Ordinance in Cagayan de Oro City, mandates all educational institutions, offices of national government agencies and private businesses to develop an ecological waste management plan that includes segregation at source and provisions for materials recovery facility.

2. With this, the field is hereby directed to segregate all waste disposal in schools. The City Local Environment and Natural Resources Office (CLEANRO) implements the "**No Segregation, No Collection Policy**" starting **October 2, 2023**. Further, repetitive disposal of mixed waste in all schools (both public and private) shall not be collected.

3. In adherence to Equal Opportunity Principle (EOP), inclusive and fair treatment shall be accorded to all participants regardless of disability, sexual orientation, gender, age, religion, and ethnicity.

4. Immediate dissemination and compliance to this memorandum is required.

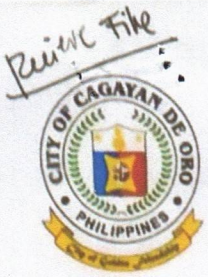

In order to implement the Waste Segregation Program in schools in accordance with the requirements of RA 9003 Article 2, Section 21 states that waste segregation must be done primarily at the source which includes residential, institutional, industrial, commercial, and agricultural sources. Additionally, Article V Section 12 of City Ordinance no. 13378-2018, also known as the Integrated Ecological Solid Waste Management Ordinance of Cagayan de Oro, mandates that educational institutions, offices of national government agencies, and private businesses develop an ecological waste management plan that includes segregation at source and provisions for materials recovery facilities.

Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000, provides for an ecological solid waste management program, creates the necessary institutional mechanisms and incentives, declares certain acts prohibited and provides penalties for violation.

In line with this, this office would be implementing the "No Segregation, No Collection Policy" starting October 2, 2023. Further, **repetitive disposal of mixed waste in all school (both public and private) shall not be collected.**
