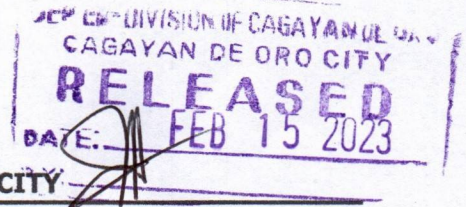

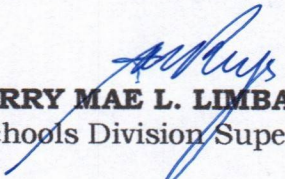

3. This Office directs immediate and wide dissemination of this Memorandum.

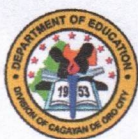
