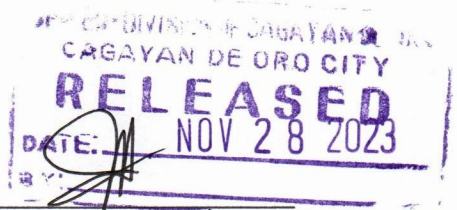

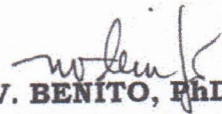

1.
