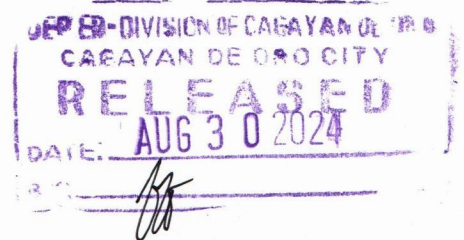

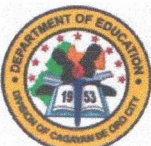

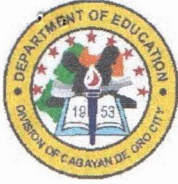
**PARTICIPATION IN THE 2024 3RD QUARTER JOINT MEETING OF

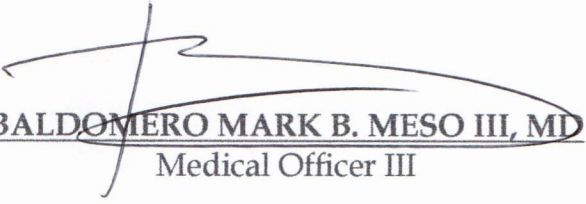
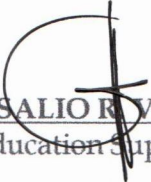

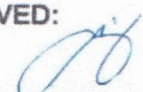
