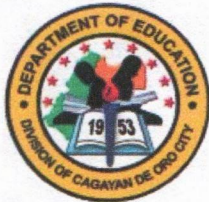
3. Attendance to these 16th National Congress and Seminar-Workshop of the Department of Education – National Employees Union clustered shall be on official business.
