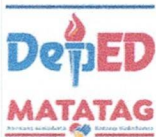

The Department of Health Center for Health Development - Northern Mindanao (DOH CHD-NM) recently hosted an orientation for the public and private sectors within the region. This initiative was part of the broader implementation of Joint Administrative Order (JAO) No. 2023-0001, issued by the Department of Health (DOH), the Department of Labor and Employment (DOLE), and the Civil Service Commission (CSC) on April 5, 2023. The JAO aims to establish a National Policy Framework for the Promotion of Healthy Workplaces, in alignment with DOH-CSC-DOLE Joint Memorandum Circular No. 1 s. 2020.
