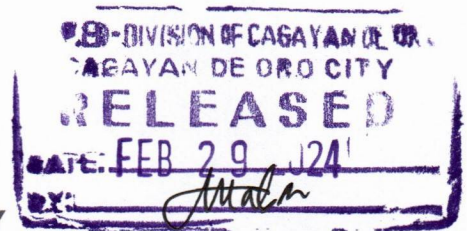

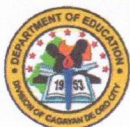

1. The Department of Education Division of Cagayan de Oro City through the School Governance Operations Division (SGOD) will conduct a 4-Day Seminar-Training for Quick Response Team on **March. 7 to 10, 2024** at Camiguin Highland Resort, Camiguin Province.
2. This activity aims to orient DepEd Personnel on the basics of life support, rescue and first aid and build the capacities needed to efficiently manage all types of emergencies and disasters.

All concerned DepEd personnel are directed to be at the division office **on March 7, 2024 at exactly 2:30 AM** for the early departure.
