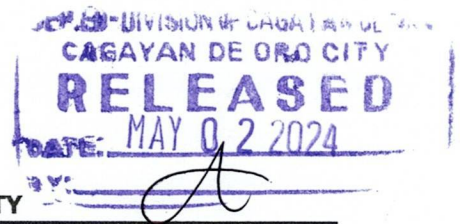

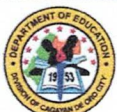

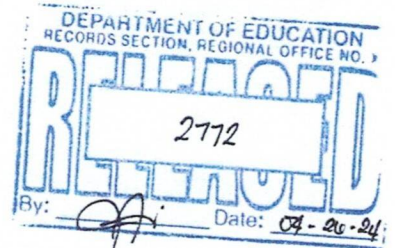

- Regarding the issued **Regional Memorandum No. 054, s. 2024** titled **2024 Regional Schools Press Conference (2024 RSPC)**, the participants' meals, travel, and other expenses shall be charged to SEF/local funds and other fund sources, subject to the usual accounting and auditing policies, rules, and regulations.
- A membership fee of Thirty Pesos (P30.00) for campus journalists and Sixty Pesos (P60.00) for school paper advisers will be charged for each participant to defray the expenses for the tokens of the outstanding campus journalists. These fees, along with the membership fee for the RSPC and NSPC organizations, shall be chargeable against the school MOOE/local/SEF/School Campus Journalism Fund or any other available funds, subject to the usual accounting and auditing rules and regulations.
- Other provisions in the previous Memorandum remain in effect.
