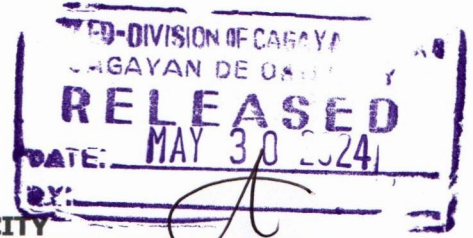

4. Immediate compliance with this Memorandum is desired.

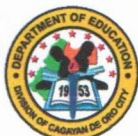

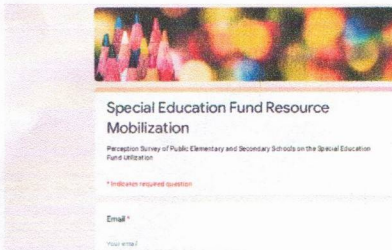
