**RELEASE OF THE CERTIFICATE OF RATING (COR) OF THE PHILIPPINE
EDUCATIONAL PLACEMENT TEST (PEPT) – SPECIAL AND REGULAR TESTS**

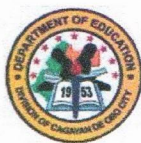
1. All concerned are hereby informed that the Certificates of Rating of the Philippine Educational Placement Test (PEPT) for the Special and Regular Tests are now ready for release. Releasing schedule is from Monday to Friday during office hours at the Private Schools Office, Division Office, Masterson Ave, Upper Balulang, Cagayan de Oro City.

2. **Guidelines on the Effectivity of Grade Level Placement of PEPT Qualifiers:**

- a. **PEPT-Regular:** Pursuant to DepEd No. 55 s.2016, "Policy Guidelines on the National Assessment of Student Learning for the Kto12 Basic Education Program", the placement of PEPT qualifiers who took the test during the field office, walk-in, and special (onsite request) administrations **shall take effect in the next or subsequent school year, NOT** during the current school year when the test was administered.
- b. **PEPT-Special:** In reference to DepEd Memorandum No. 49 s.2023, "Administration of the 2023 Special Philippine Educational Placement Test" (PEPT), the placement of the PEPT qualifiers who took the 2023 Special PEPT **shall take effect in the current school year when the test was administered.**

3. Concerned school heads should coordinate with the Division Planning Officer for the LIS process concerning the PEPT result.

4. **Advisory to University and College Registrars/Admission Officers/Principal and School Heads:** In compliance with the mandate of DepEd Memorandum No. 284 s.2005 and CHED memorandum Order No. 15 s.2003, you are hereby advised to institute precautionary measures in the acceptance
