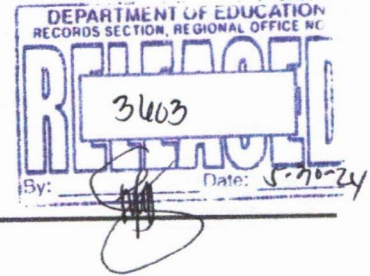

**PREPARATION OF THE PARTICIPANTS' DOCUMENTS
FOR THE 2024 PALARONG PAMBANSA**

To: Schools Division Superintendents
All Others Concerned

1. Regarding upcoming Palarong Pambansa 2024, the Regional Screening and Accreditation Committee (RSAC) Chair, together with the RSAC Data Group, will conduct the pre-screening of the documents of the athletes, coaches, assistant coaches, and chaperons for the 2024 National Screening and Accreditation on June 22-24, the venue of which will be announced in a separate memorandum.
2. For individual sports, since the athletes' documents might come from the different divisions, the division sports officer or his/her representative shall gather the athletes' documents in their division and submit them to the RSAC Data Group.
3. For the athletes' gallery, the coaches shall coordinate, prepare, and submit an electronic copy of the gallery to the RSAC Data Group. For uniformity, the athletes, coaches, assistant coaches, and chaperons shall wear an orange t-shirt during their photo shoot against a white background. Failure of the coach to comply with this provision shall be a reasonable cause for the NMRAA to exercise its discretion to replace the coach with another qualified personnel.
4. Before submitting the documents, the athletes, coaches, assistant coaches, and chaperones shall undergo another medical examination while the elementary athletes shall undergo another dental examination. All shall secure a prescribed medical certificate filled out by a medical doctor.
5. The division sports officer or his/her representative shall submit the documents to Mr. Edgardo V. Yanez, Principal II, Bulua Central Elementary School, Cagayan de Oro City, on or before June 13. Non-submission of the required documents as per deadline shall be a reasonable cause for the NMRAA to exercise its discretion to replace the athletes, coaches, assistant coaches, or chaperons.
6. The RSAC Chair and the RSAC Data Group shall conduct a comprehensive pre-screening at Bulua Central Elementary School, Cagayan de Oro City, on June 13, 14, 17, and 18.

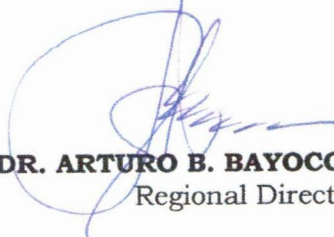
