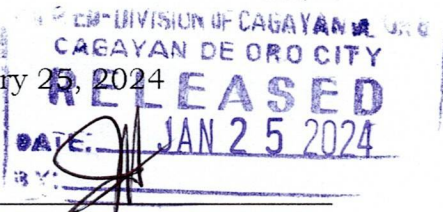

**REITERATION OF DEPED ORDER NO. 013 S, 2022 - OMNIBUS GUIDELINES
ON THE REGULATION OF OPERATIONS OF PARENT-TEACHERS ASSOCIATION**

1. In reference to **DepED Order No. 013 s, 2022** dated March 18, 2022 and titled **Omnibus Guidelines on the Regulations of Operations of Parent-Teacher Associations**, this Office hereby **reminded** the field to **strictly observe the provisions contained within**.
2. Particular attention is invited to the following provisions of the said Order, to wit:

ARTICLE VI. ALLOWED AND PROHIBITED ACTIVITIES OF A PTA

“Section 24. Allowed PTA Activities

A PTA, whether officially recognized or not, is allowed to conduct activities that will directly support the learners, teaching and non-teaching personnel, school, other parents/guardians, and community as enumerated under this section. All PTA activities within the school premise or which involve the school, its personnel or learners shall be with prior consultation and approval of the school head. The activities that may be conducted by a PTA shall be based on the following:

24.1 Support to Learners

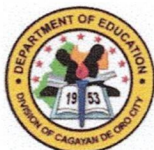

Section 25. Prohibited PTA Activities or Acts of PTA Officers

25.1 PTAs and their officers are prohibited from performing the following:

Xxx

25.1.5 using the name of the school for unauthorized solicitation of financial or other resources from private donors or stakeholders;

25.1.6 charging any service fees against amount collected from VSCs;

25.1.7 engaging in fundraising activities in excess of what is allowed under Section 23.1.5.1; and

25.1.8 such other acts or circumstances analogous to the foregoing.

25.2 Any violation of the provisions of this section shall be dealt with corresponding sanctions as provided under Section 32 hereof."

3. Additionally, school heads, teachers and other school personnel are **strictly prohibited from soliciting or collecting any form of contribution** from parents or legal guardians, volunteers, partners, and stakeholders as provided for in **Section A (2) of DepED Order No. 021, s. 2023** dated August 3, 2023.
4. Immediate dissemination of and compliance of this Memorandum is directed.
