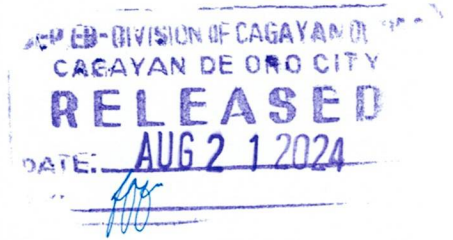

TROOP LEADERSHIP TRAINING OF TEACHERS**

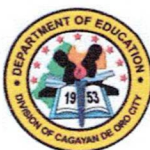

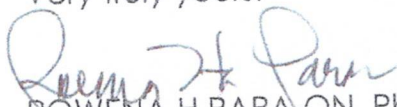
