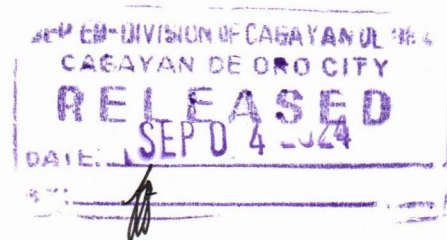

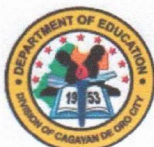

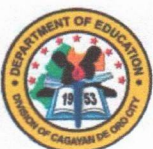
concerns affecting the operation of the Union and other matters.

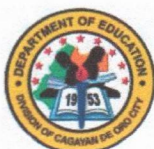

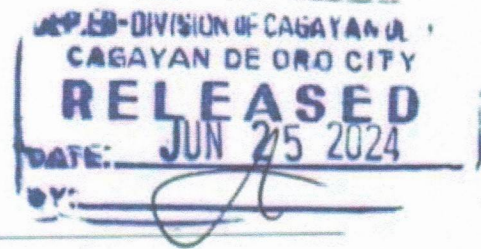

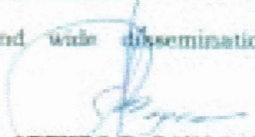
