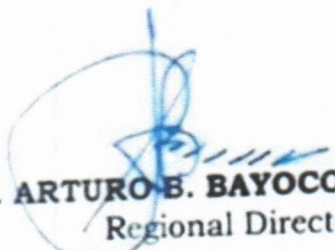
INTENSIVE MONITORING OF PISA 2025 PREPARATIONS

1. This Memorandum outlines the schedule and activities for the **Intensive Monitoring of the Programme for International Student Assessment (PISA) 2025 Preparations**.
2. An online meeting will be held on November 7, at 10:00 a.m., which will be participated in by the following personnel from the Regional Office (RO) and the Schools Division Offices (SDOs):
 - a. ~~Assistant Schools Division Superintendents (SDOs)~~
 - b. ~~Chiefs (RO, CID, and SGOD)~~
 - c. ~~Education Program Supervisors (RO and SDOs)~~
 - d. ~~Public Schools District Supervisors (SDOs)~~

3. The agenda will include updates and the monitoring plan for PISA preparations.

5. All the SDOs shall create their Division Teams to monitor the daily reviews and other PISA preparation initiatives.
6. The intensive onsite monitoring of PISA 2025 preparations will be conducted by the RO officials, together with the Division Teams composed of personnel from the CID and the SGOD, on November 11-15.
7. Interdivisional monitoring by the SDO officials will be conducted in the SDOs within the Province on November 20-22.

8. The information gathered from the monitoring activities on November 11-15 will be presented at the Regional Management Committee (ManCom) Meeting on November 18.
