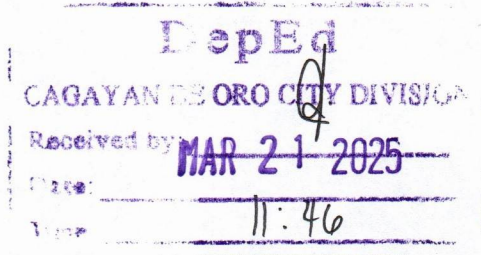

SPECIAL PERMIT

PERMIT IS HEREBY GRANTED to **THE DANCESPORT**, Cagayan de Oro City, represented by: **MR. JOSE A. AWITEN** – Training Director, **TO USE THE CITY TOURISM HALL on March 1, 2, 29 and 30, 2025, from 10:00AM – 4:00PM**, for Launching on Dancesport, subject however, to the following conditions;

1. That PEACE and ORDER is strictly maintained;
2. That PUBLIC SAFETY shall be strictly imposed;
3. **That Cleanliness of the surroundings shall be strictly observed;**
4. That the herein permittee shall coordinate and compel to follow the provisions set by the National and Local IATF guidelines on COVID-19, Department of Tourism (DOT) issuances, since the CDOC will be under Alert Level 1, Strict compliance of the recommended minimum public health standards and all participants must have been fully vaccinated;
5. **That health standards and protocols such as but not limited to proper wearing of face mask, observance of social or physical; distance ng and frequent sanitation;**
6. That the **streets/road along specified area shall NOT be utilized** during the said activity in order not to hamper the traffic, thereat;
7. That Loud music shall be prohibited to prevent customers from conversing in loud voices where saliva might spew from the speaker unto other persons;
8. That the user/permittee shall be responsible and/or liable for payment of whatever damage incurred upon **said vicinity** and/or its premises as a result of the activity, which the user/permittee had been permitted to conduct in **said vicinity** and/or its premises;
9. That there shall be **no alteration** of the **structural part** of the same;
10. That **no decorations** such as bunting, streamers, booths and other sorts of décor **shall be left** in the **said vicinity** and its premises, but shall be carried and **thrown away** by the user or the **applicant**;
11. That the use of **CONFETTI** or any similar materials is strictly prohibited;
12. That in no case shall a **Pyrotechnics, Flammable Materials and Explosives** be and **utilized or exploded** during the said activity;
13. That this **permit** may be **cancelled or revoked** in the event the **City Government** or any agency holding government related/supported activities; and
14. That **extant law, rules, regulations, City Ordinances and other provisions** of the law **pertinent and relative thereto** are **observed, adhered to and complied with.**

This **PERMIT** shall be shown to all agents of the law upon demand for proper check-up and/or verifications.
