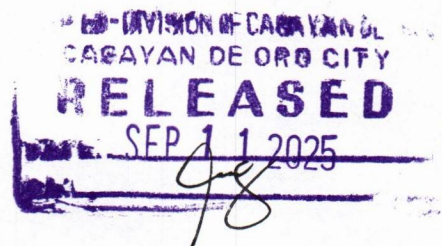

BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP)**

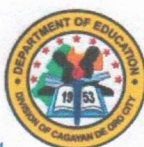

Participation to this activity shall be on voluntary basis as such, participants themselves shall shoulder any registration fees, and travel/incidental expenses.

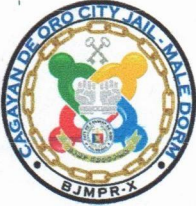

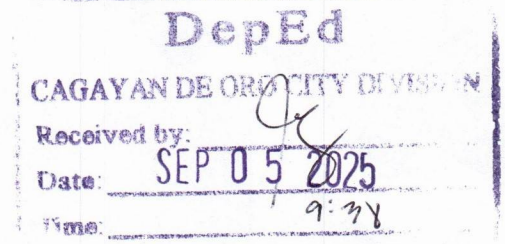

The Cagayan De Oro City Jail – Male Dormitory will organize **"PAGPAHI-ULI RUN"** a Run for a Cause activity. The activity will be on **October 12, 2025 (Sunday)** at exactly 3:00 o'clock in the morning (Assembly time) at Kiosko Kagawasan to Bulua Banga, Cagayan de Oro City.

In line with the observance of the National Correctional Consciousness Week (NACOCOW) 2025, pursuant to Presidential Proclamation No. 551, The activity serves as a **fund-raising initiative to support the programs** of our jail, which play a vital role in the development and welfare of our PDL:

- a. To support the livelihood programs of PDL;
- b. To support the Drug Dependency Examination (DDE) fees needed by PDL with drug-related cases;
- c. To provide additional medical supplies and medications for PDL;
- d. To construct specialized facility for PDL with special needs

The said fun run will be having three categories

- **3 Kilometers Category:** Registration fee **P450.00**
(Route: **Kiosko Kagawasan** going to **Velez St.** then **Sabal Hospital** turn left to **Marcos Bridge (Turning Point)** and **vice-versa**)
- **5 Kilometers Category:** Registration fee **P650.00**
(Route: **Kiosko Kagawasan** going to **Velez St.** then **Sabal Hospital** turn left to **Marcos Bridge to RER Phase II (Turning Point)** and **vice-versa**)
- **10 Kilometers Category:** Registration fee **P850.00**
(Route: **Kiosko Kagawasan** going to **Velez St.** then **Sabal Hospital** turn left to **Marcos Bridge to RER Phase 2-Kauswagan Highway**, going to **Bulua Banga (Turning Point)** and **vice-versa**).

Participants will be provided with event shirt/race bib and medal for **10KM finishers**. Further, each of the top two (2) biggest delegations will also receive a plaque of recognition.
