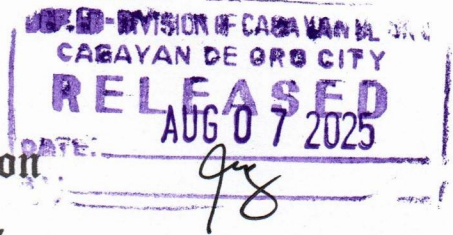

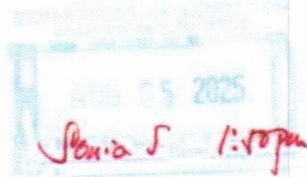

Travel expenses of participants from the field offices shall be charged against their respective local funds.

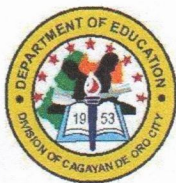
Expenses for board and lodging as well as travel expenses of participants from the DepEd Central Office shall be charged against EWD Funds.

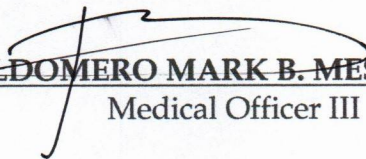
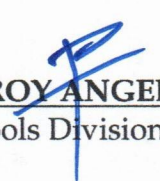
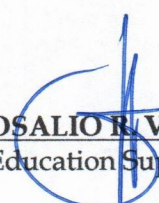
