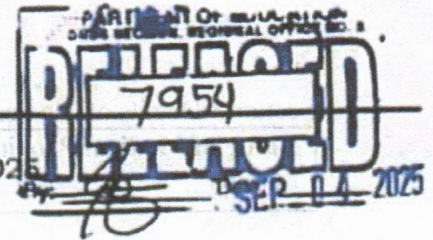

- capacitate the members of the Regional/Division Screening and Accreditation Committee on the revised rules on screening and accreditation of athletes and coaches for the Palarong Pambansa 2025;
- enhance the system for the digitization of documents, preparation of PasSport for athletes/coaches/assistant coaches, and finalization of the masterlist; and
- express commitment in ensuring the protection of athletes' rights pursuant to DepEd Order No. 40 s. 2012 also known as Child Protection Policy and RA 10676: Student-Athletes Protection Act.

Target participants to the Conference are the chairpersons of the Regional Screening and Accreditation Committee (RSAC) and Division Screening and Accreditation Committee (DSAC) or their respective authorized representatives, the members of the National Screening and Accreditation Committee (NSAC), regional sports officers and their respective IT personnel, National Academy of Sports (NAS), members of the Palarong Pambansa Secretariat, and other relevant offices.

Participants are expected to be at the venue on **September 15, 2025** and the first meal to be served is **Breakfast**. The last meal to be served is **Dinner on September 18, 2025**.

Expenses such as food and accommodation of all participants, and travel expenses of the members of NSAC, personnel of the Palarong Pambansa Secretariat and other offices shall be charged against the 2025 Physical Fitness and School Sports (PFSS) Funds, while travel expenses of the RSAC/DSAC chairpersons and/or representatives, Regional Sports Officers (RSO) and ICT representatives shall be charged against their respective MOOE/local funds, subject to the usual government accounting and auditing rules and regulations.
