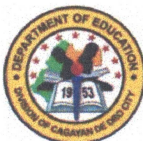
**REQUEST FOR ACCREDITED TECHNICAL OFFICIALS OF PENCAK SILAT

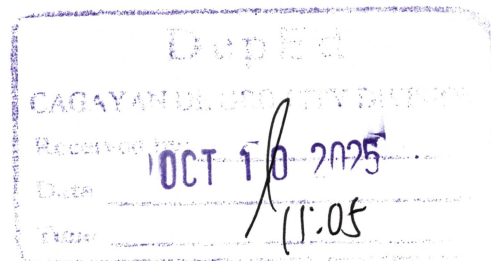
