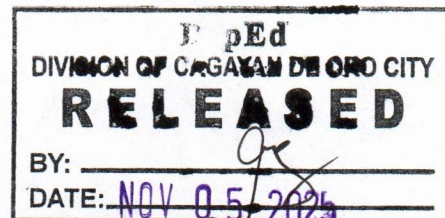

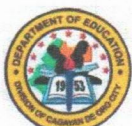
PARTICIPATION TO THE ADVOCACY RUN IN LINE WITH THE 33RD NATIONAL CHILDREN'S MONTH CELEBRATION

1. Relative to **Regional Memorandum No. 825, s. 2025**, titled "*Re: National Children's Month Celebration*," the Department of Education Regional Office X will conduct an **Advocacy Run** on November 7, 2025, 5:00 am at Rio de Oro Boulevard, as one of the major activities in observance of the **33rd National Children's Month Celebration** with the theme: "*OSAEC-CSAEM Wakasan, Kaligtasan at Karapatan ng Bata Ipaglaban.*"
2. The Advocacy Run will be participated in by DepEd officials, personnel, learners, and partner agencies, symbolizing unity in the promotion and protection of children's rights and well-being. The details of the fun run are as follows:
 - **1K Run:** Route – *Puntod Entrance Boulevard to 500 meters, and vice versa*
 - **3K Run:** Route – *Puntod Entrance Boulevard to Consolacion Junction, and vv*
 - **5K Run:** Route – *Puntod Entrance Boulevard to J.R. Borja Boulevard, and vv*
3. In view of this, all *public secondary schools* in this division are encouraged to participate by sending **one (1) Learner Rights and Protection (LRP) Focal Person** and **one (1) Learner Representative** to the said activity. Participation of school representatives shall be on a **voluntary basis**. Learner participants shall be required to **secure a duly signed Parent's Consent Form** (Annex C) prior to their participation in the event.
5. In adherence to Equal Opportunity Policy (EOP), inclusive and fair treatment is accorded to all participants regardless of age, gender and sexual orientation, disability, religion, and ethnicity.
6. Immediate dissemination of this memorandum is desired.

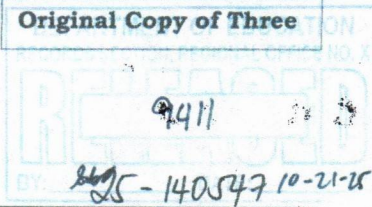

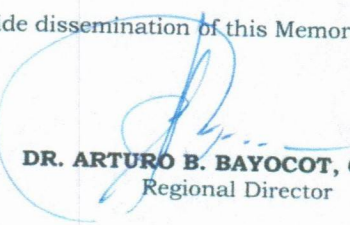
