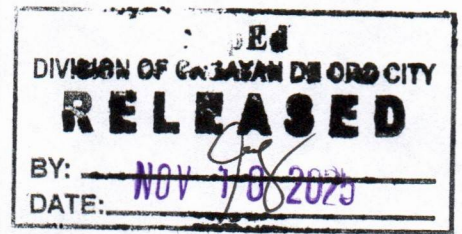

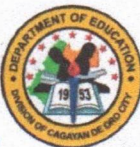

**POST-EVALUATION OF 2025 BRIGHT AND STRATEGIC PLANNING FOR
ADDITIONAL BERF FUNDING FOR CY 2025**

1. In line with the continuing efforts to strengthen the Division's research management system, the Planning and Research Unit will conduct a one-day **Post-Evaluation of 2025 BRIGHT and Strategic Planning for CY 2026** on **November 17, 2025**, from **8:00 a.m. to 5:00 p.m.** at the **SBM Office, Cagayan de Oro National High School - JHS**.
2. The activity aims to assess the implementation of 2025 BRIGHT, revisit the efficiency of existing processes such as the **Call for Proposals, Monitoring, and Dissemination**, and formulate strategies to further enhance the quality, efficiency, and utilization of research at the school, district, and division levels.
3. Specifically, the activity aims to:
 - a. review the implementation of 2025 BRIGHT;
 - b. plan and align the January-April 2026 schedule for submission and evaluation of BERF and Non-BERF research proposals;
 - c. discuss the evaluation and approval process for completed research papers; and
 - d. formulate strategies to strengthen research utilization at the school, district, and division levels; and
 - e. facilitate preparations for the additional BERF budget allocation.

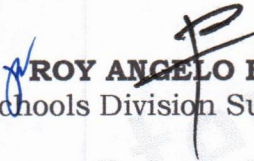

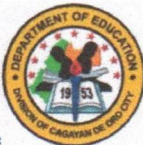

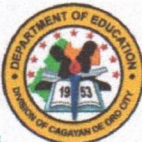
