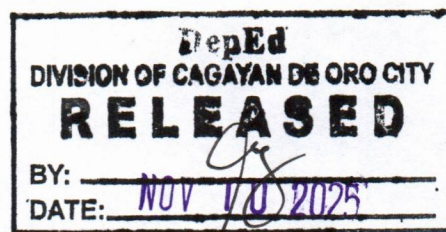

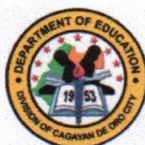
**CORRIGENDUM AND ADDENDUM TO DIVISION MEMORANDUM NO. 942, S. 2025

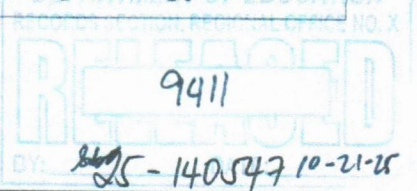
