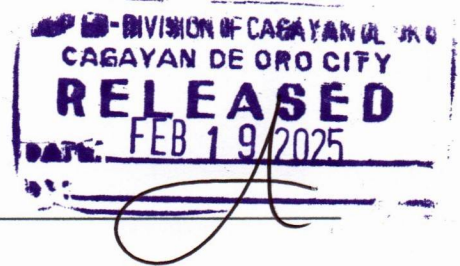

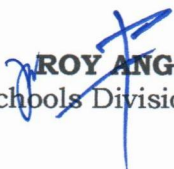
1. The field is hereby informed of the replacement of some Technical Officials of identified sports events during the conduct of the 2025 Division Athletic Meet.
