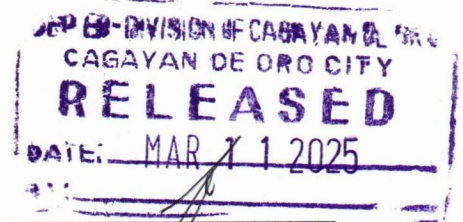

1. For the guidance of all concerned Private and Public Elementary and Secondary School Heads, this Office reiterate DepEd Memorandum No. 376, s. 2024 titled Final Call on the Confirmation of LIS Transfer Requests and Immediate Response to School Requests on the Transfer of SF 10 for S.Y. 2023-2024.

2. As the School Year Ends on **April 15, 2025**, all private and public schools are expected to have finalized all confirmation of LIS transfer requests and immediate response to school requests on the transfer of SF 10 for S.Y. 2024-2025, First Semester and Second Semester. It is also expected that by **April 01, 2025**, all LIS issues are resolved, including LIS enrolment issues of the Second Semester which started last December 4, 2024. Related issues indicated below are expected to be resolved before the indicative date:

2.1 Pending Enrollment Issue: Pending School Acknowledgement, Pending Division Approval, Request to Reopen LIS System for Previous S.Y. Enrollment,

2.2 Pending Transfer Confirmation: Disputed Transfer, Joint Transfer,

2.3 Pending LRN Approval: School Acknowledgement of

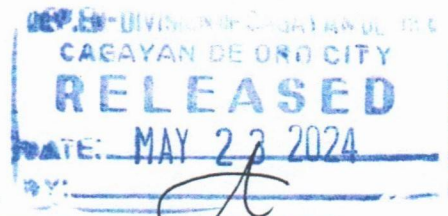

1. This Office emphasizes the Final Call on the Confirmation of LIS Transfer Requests and Immediate Response to School Requests on the Transfer of SF 10 for S.Y. 2023-2024, First Semester and Second Semester on **May 27, 2024**, as the LIS Second Semester Enrollment started last February 1, 2024.

2. All Cagayan de Oro City schools offering K to 12 Basic Education Curriculum Program are directed to follow DepEd Order No. 3, 2018, on Basic Education Enrollment Policy and DepEd Order No. 54, s. 2016 on Guidelines on the Request and Transfer of Learners School Records to avoid rising LIS-related issues and concerns that include:

- A. Pending Enrollment Issue: Pending School Acknowledgement, Pending Division Approval, Request to Reopen LIS System for Previous S.Y. Enrollment,
- B. Pending Transfer Confirmation: Disputed Transfer, Joint Transfer,
- C. Pending LRN Approval: School Acknowledgement of Approved/Disapproved LRN,
- D. System Glitches and other Learner Information System Issues and Concerns encountered.

3. School heads and system administrators are required to follow DepEd Order 26, s. 2015, DepEd order 27, 2019, and the LIS tutorials on the Support Tab for their references in utilizing the LIS accurately. They are encouraged to take appropriate action to facilitate the resolution of the enrollment and transfer issues and to coordinate with their respective Division LIS-BEIS System Administrators for proper technical assistance.
4. Schools with pending requests for Confirmation of transfer out of students with **unsettled accounts** shall respond by **clicking the confirm button and ticking the account box on the confirm page**. The immediate confirmation of transfer requests will help private schools use LIS to track learners with financial obligations and identify the learners tagged as **"temporarily enrolled."**
5. At the end of the school year, schools that have been found **"LIS Not Finalized"** for the **past two years will have their LIS Account Access closed effective School Year 2024-2025**.
6. The list of LIS Coordinators in Enclosure 1 is attached to help ensure 100% finalization of the Division Learner Information System, EOSY Status S.Y. 2023-2024 and BEIS Status as of May 22, 2024. (kindly coordinate with the planning office)
