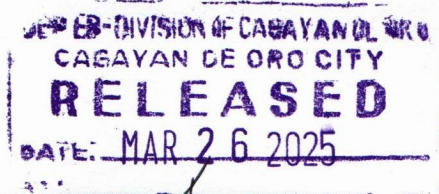

ANTI-ONLINE SEXUAL ABUSE AND EXPLOITATION OF CHILDREN**

1. To underscore DepEd CDO's commitment to child protection and in partnership with the Special Justice Zone, an **Information Dissemination Campaign Program on Anti-Online Sexual Abuse and Exploitation of Children (OSAEC)** will be conducted on **March 28, 2025, from 9:00 AM to 12:00 NN** at **Cagayan de Oro National Junior High School**.
2. This initiative aims to: (a) Raise awareness on the dangers and impact of OSAEC on children; (b) Equip educators and school personnel with the knowledge and strategies to prevent and address OSAEC cases; (c) Strengthen collaboration among schools, government agencies, and stakeholders in ensuring a safe environment for all learners; (d) Empower students, parents, and school communities to recognize and report cases of child abuse and exploitation.
3. The concerned school head is requested to facilitate the participation of 500 Junior High School students and ensure proper coordination with our partners in the Special Justice Zone. Participants are encouraged to actively engage in discussions and activities during the program.
4. In adherence to the Equal Opportunity Policy (EOP), inclusive and fair treatment is accorded to all participants regardless of age, gender and sexual orientation, disability, religion, and ethnicity.
