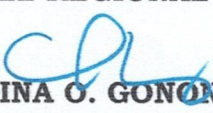

Teacher-participants may also be granted vacation service credits, in accordance with existing policies. Furthermore, all Regional Offices are requested to submit the names of their participants on or before April 22, 2025, using the template provided in Annex 1.

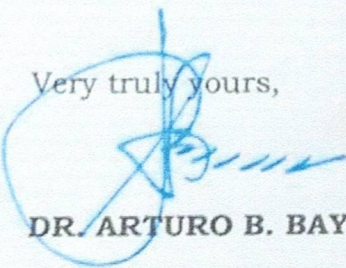
