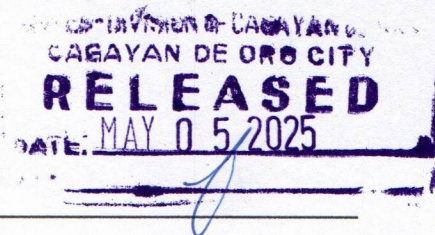

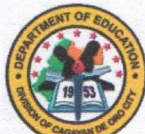
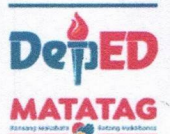

1. This is in reference to Memorandum DM-OUOPS-2025-01-02592 issued by Mr. Malcom S. Garma, Assistant Secretary and Officer-in-Charge of the Office of the Undersecretary for Operations.
