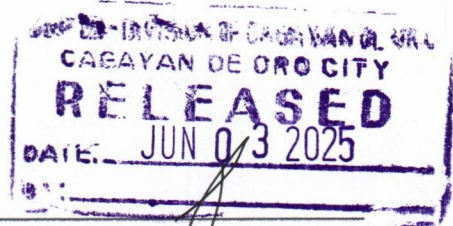

CONVENTION OF DEPED ACCOUNTANTS**

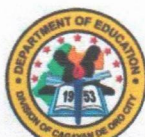
