In its thrust to engage host schools/barangays in our weekly *Klarex nga Serbisyo sa Baryo* Program through their skills and creativity, I am pleased to inform you that the City Government will be holding the *Klarex nga Serbisyo* Presentation Contest exclusively for Cagayan de Oro-Department of Education Personnel.

Please find hereunder the details of the competition, to wit:

KLAREX NGA SERBISYO PRESENTATION CONTEST FOR DEPED PERSONNEL

MECHANICS:

1. All DEPED Teaching and Non-Teaching Personnel at the scheduled *Klarex nga Serbisyo* school are encouraged to participate. However, City government and barangay detailed personnel, and student teachers are not allowed in the performance.
2. Only DEPED Personnel who are regularly assigned to the host school during the scheduled KSB are eligible to join the presentation, and no personnel from other schools are allowed to participate in the performance.
3. Each group must strictly adhere to a minimum of 4 minutes and maximum of 6 minutes performance duration, including entrance and exit.
4. Presentations may be: comical skits, dance, song, or a combination of various performance styles;

5. Props and costumes are permitted for enhancement, given that they are decent and not obscene; and any form of stunts and use of live animals, confetti, and other environmental hazards are strictly prohibited to maintain safety and cleanliness.

6. School Principals/ Heads must actively participate in the presentation, setting an example for their respective teams.

7. Schools shall coordinate with the City Information Office to make necessary arrangements for the coverage of their performance to ensure better quality and smooth facilitation; and to the City Public Services Offices ahead of time for physical set ups, such as the stage, and other related arrangements

8. The City Information Office shall be in charge of the compilation of all performances for review and finalization of scores for the judges.

9. A 2-point deduction from the overall total score shall be enforced for every mechanic violation.

9. Judging shall be done during performance however subject for review and finalization by the end of this year's round of Klarex nga Serbisyo sa Baryo.

10. Winning group is set to receive the amount of Three Hundred Thousand Pesos (Php300,000.00).

CRITERIA FOR JUDGING:

Performance (Synchronization, Timing, Projection and Energy)	40%
Choreography (Creativity, Artistry, Execution, and Appropriateness of movements)	30%
Costume and Music (Color Combination, Appropriateness of Design and Style, Volume, Timing, Complementation, and Variation of Sound Beats)	15%
Entertainment/Aliw and Wow Factor (Clarity of Presentation, X-factor, and Audience Impact)	15%
TOTAL:	100%
