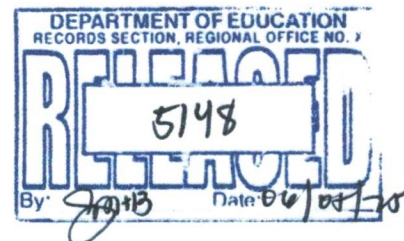

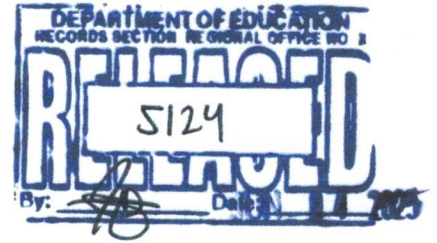

June 11: Cagayan de Oro (to be joined by Gingoog and Camiguin Divisions)

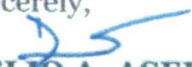
June 13: Bukidnon
