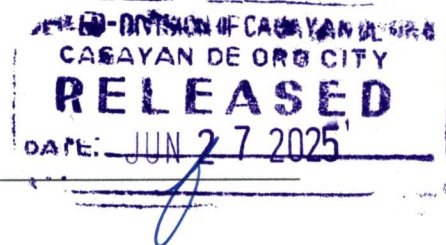

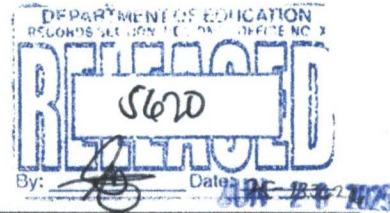

1. Following **DepEd Order No. 24, s. 2023** titled **Guidelines on the Provision of 'Supplementary Learning Resources for School Libraries and Library Hubs** and **DepEd Memorandum DM-CT-2025-148** titled **Collection Applicable Limits for the Provision Of Supplementary Learning Resources (SLRs) for School Libraries And Library Hubs / Library And Innovation Hubs** to ensure the provision of SLRs for use in public basic education schools, the Regional Office (RO), through the Curriculum and Learning Management Division - Learning Resource Management Section (CLMD-LRMS), will conduct the **Local Book Fair and Finalization of Priority Lists relative to the Procurement of Supplementary Learning Resources for School Libraries and Library Hubs** from July 30 to August 1; the venue will be specified in a separate issuance.
2. The activity intends to provide an avenue where various learning resources will be showcased and examined by various schools/SDO representatives. Through the fair, the participants are expected to finalize the priority lists, which will serve as one of the bases for procuring SLRs for school libraries and library hubs.
3. The participants from each SDO are the following:
 - a. Division LR Supervisor
 - b. Division /School Librarian
 - c. EPS In-Charge of Reading
 - d. PSDS designated by the SDS, preferably a reading specialist
 - e. 2 School Heads, Elementary
 - f. 1 School Head, Secondary
4. The first meal is breakfast on July 30, and the last meal is am snacks on August 1.
5. The participants are requested to secure their own laptop and extension cord.
6. The participants' board and lodging and meals shall be charged to the Program Support Fund (PSF) for the Provision of Supplementary Learning Resources for School Libraries and Library Hubs downloaded to the RO. Their travel expenses shall be charged against local funds, subject to the usual government accounting and auditing rules and regulations.
