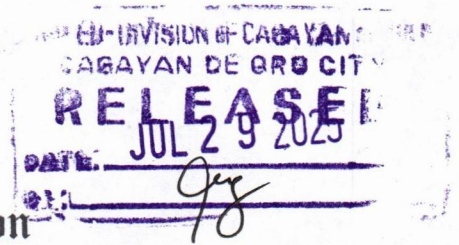

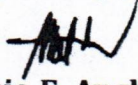

MECHANICS and GUIDELINES

1. Each district must have one entry with a minimum of three Hundred (300) members. Those who have been champions three times in the activity shall be discouraged to participate.
2. During the dance contest, each contingent must wear their school P.E uniform if available/ modified costume of their choice.
3. The minimum length of the performance is Eight (8) minutes and a maximum of Ten (10) minutes. Contingent who will go beyond or fall short based on the time provided will be penalized. Every exceeding second will get a one (1) point deduction from the total score.
4. Each group will be given one minute to prepare before the start of the routine and another one minute to leave the performance ground. Exit time will continue to run as long as there are performers/ dancers and/or props left in the performance ground. Violation of the entrance and exit time will be penalized. Every exceeding second will get a one (1) point deduction from the total score. Time will start on the first note of the music.
5. Participants' music must be submitted one day before the Competition. It must be in a flash drive bearing the school names.
6. Each contingent will perform Rhythmic pattern dance steps.
7. No vulgarity, obscenity, or explicit content is allowed.
8. Props that are not considered an integral part of a group's attire are prohibited (ex. canes, chairs, tambourines, musical instruments).
9. Removing pieces of clothing during the performance is prohibited.
10. Pyrotechnics is absolutely prohibited before, during, or after the performance.
11. No stunts and tosses shall be allowed.
12. Body/face oils or paints/other substances applied to the body or clothing that may affect the clean dry surface of the ground and the safety of fellow contingents are prohibited.
13. The ground is available for each participant to use for their performance.
14. There will be three winners of the contest: Champion, 1st Runner-up, and 2nd Runner-up. Winners will receive a certificate of recognition, a trophy/ Plaque, and a cash prize.
15. Judges' decisions are final and irrevocable.

16. The dance showdown/presentation will be judged according to the following criteria.

CRITERIA FOR JUDGING

1. Choreography (Creativity, Variety of floor patterns, Dance Styles & Difficulty) – 40%
2. Performance (Musicality, Group Execution, Synchronization & Spacing) – 30%
3. Overall Effect (Showmanship, Intensity, Projection) – 20%
4. Props and costume/attire – 10%

TOTAL: 100%

SCHEDULE OF ACTIVITY

1. The Rhythmic Field Demonstration Competition will be held on August 25, 2025, at 8:00 o'clock in the morning at Pelaez Sports Center.
2. Deadline for the submission of the Registration Form shall be on or before August 01, 2025.
3. Drawing of lots for the order of presentation will be done on August 24, 2025. The number drawn by each Contingent will determine the order of the showdown. Call time for Contingent will be one (1) hour before the start of the contest. Late participants 5 points deduction from the total score.
4. Final blocking shall be on August 24, 2025 at 8:00am - 12:00nn at Don Gregorio Pelaez Sports Center.

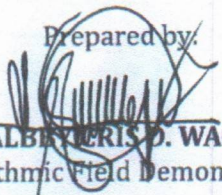

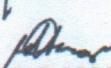
