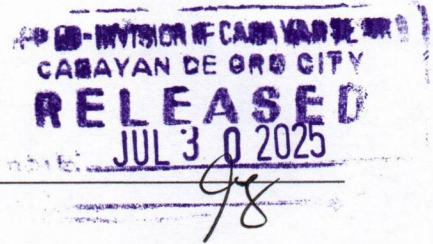

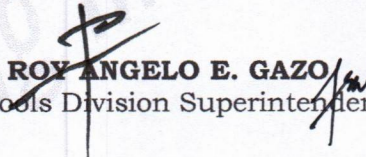

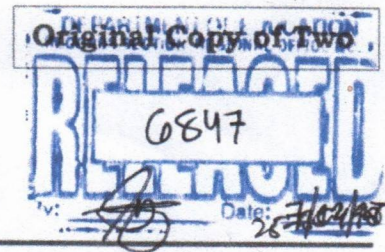

1. Regarding **Regional Memorandum No. 458, s. 2025 on Local Book Fair and Finalization of Priority Lists relative to the Procurement of Supplementary Learning Resources for School Libraries and Library Hubs**, the activity at NEAP-RX, Lapasan, Cagayan de Oro City, has been rescheduled for August 16-18.
2. Service credits or compensatory time off (CTO) computed against the actual days the participants served may be requested in accordance with the provisions of DepEd Order No. 52, s. 20023 and CSC-DBM Joint Circular No, 2, s. 2016.
3. The participants' travel and incidental expenses shall be downloaded to the Schools Division Offices (SDOs), subject to the usual accounting and auditing rules and regulations upon submission of the required documents. If the downloaded funds for travel are insufficient, the excess amount shall be charged against local funds. The participants shall select the most cost-effective mode of travel, ensuring prudent use of resources while maintaining reasonable comfort and efficiency.
