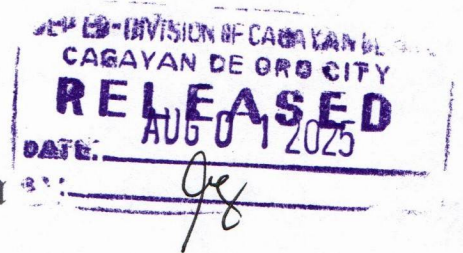

1. Pursuant to the attached **Regional Memorandum**, the DSWD-10, in coordination with the RIACAT-VAWC, will conduct a 1-day orientation on Republic Act No. 11862 (Expanded Anti-Trafficking in Persons Act of 2022) and Republic Act No. 11930 (Anti-Online Sexual Abuse and Exploitation of Children Act of 2022). This activity is intended to capacitate school child protection focal persons on relevant child protection laws addressing trafficking and online exploitation.

The orientation will be held on **August 4, 2025**, at AVC, 3rd Floor, DepEd Regional Office X, and will be participated in by **21 identified** division and school personnel who are members of the CPC in their schools. 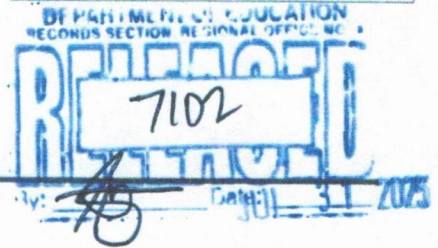

CHILD PROTECTION FOCAL PERSONS AGAINST TRAFFICKING AND
ONLINE EXPLOITATION: 1-DAY ORIENTATION ON RA 11862
AND RA 11930 IN PARTNERSHIP WITH DSWD-10 AND RIACAT-VAWC

To: Schools Divisions Superintendents
All Others Concerned

1. Coordinating with the Department of Social Welfare and Development-10 (DSWD-10) and the RIACAT-VAWC, this Office will host the activity titled **Strengthening the Frontline: Child Protection Focal Persons against Trafficking and Online Exploitation** at the Audiovisual Center (AVC), Third Floor, DepEd Regional Office X, on August 4.
2. This orientation aims to strengthen the capacity of child protection focal persons in implementing RA 11862 (Expanded Anti-Trafficking Act) and RA 11930 (Anti-OSAEC/CSAEM Act).
3. With the DSWD citing several recorded cases of OSAEC/CSAEM in Cagayan de Oro City, the Division of Cagayan de Oro City shall have a total of **21 participants** composed of the division LRP focal person, alternate focal person, and identified school heads or school personnel who are members of the Child Protection Committee in their schools.
4. All other SDOs must send **three participants** composed of the division LRPO focal persons, alternate focal persons, and school heads or school personnel who are members of the Child Protection Committee, preferably from schools who have recorded LRP cases.
5. Travel and other incidental expenses shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
