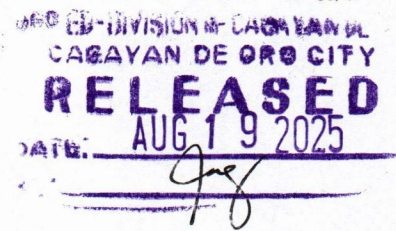

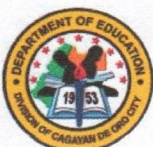

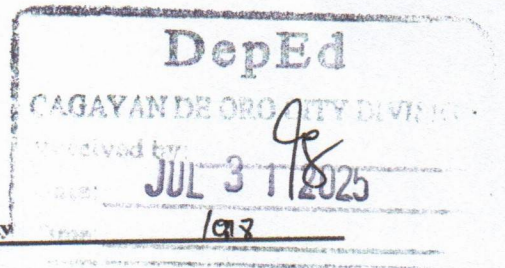

I firmly believe that Scouting activities such as these develop patriotism and responsible citizenship in our youth and are congruent with our department's vision, mission, and core values.

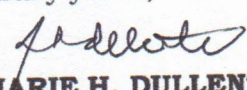
The undersigned would also like to request approval for a 2-day service credit as per DO 53 s.2003 updated guidelines on grants to all teachers who will be participating in the said event.
