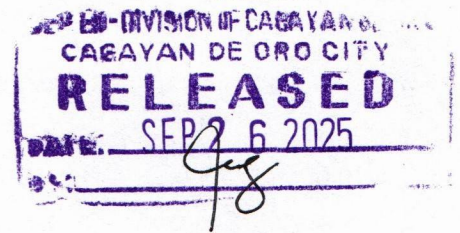

**ADDENDUM TO DIVISION MEMORANDUM NO. 739 S. 2025 ON THE
